The COM’s role is to serve the presbytery in the best interest of our member churches. Should there be concerns about someone from the Pulpit Supply List who has filled your pulpit, please have the Clerk of Session contact your COM Liaison so we may discuss your concerns.

PULPIT SUPPLY POLICY

It is the responsibility of the Session to provide for the worship of the people of God, including the preaching of the Word (G-10.0102-b). Those who may be invited to preach the Word include:

1. Elder within their own congregation
2. Members of a local congregation
3. Those on the approved Pulpit Supply list. It is the expectation that Worship Committees will use this list to fill the pulpit if there are not Elders and/or members in the local church who are willing to fill the pulpit.
4. No pulpit supply shall supply a particular church more than two Sundays per month, nor shall a church request a pulpit supply to do so. (Addition to policy by COM on March 21, 2013.)

CRITERIA FOR INCLUSION ON THIS LIST: Inclusion on the list is at the discretion of the Committee on Ministry. Inclusion requires a written request to the COM.

1. If a Member-at-Large in the presbytery you must make the request.
2. If clergy of a denomination in communion with the PCUSA either through Full Communion: Evangelical Lutheran Church of America, Reformed Church of America and the United Church of Christ, and/ or Churches Uniting in Christ: African Methodist Episcopal Church, African Methodist Episcopal Zion Church, Christian Church (Disciples of Christ), Christian Methodist Episcopal Church, Episcopal Church, International Council of Community Churches, Moravian Church Northern Province, United Church of Christ, United Methodist Church, you must generate the request and the request must be accompanied by certification of your ordination and the name of a denominational reference. This will include a conversation with a team from the COM.
3. Clergy from other denominations in correspondence will be considered on a case-to-case basis following the same process.
4. If an Elder, whether active or inactive, in the PCUSA has completed the Lay Pastor Training, the Session of the church in which s/he is a member must make the request for inclusion on the Pulpit Supply List. This request should include the name of the person who taught the preaching course the Elder took in the Lay Pastor Training program so COM can obtain an evaluation of the readiness to be included on the list.

OTHER OBSERVATIONS: It should be noted that because a person has completed the Lay Pastor Training this does not automatically designate them as a Commissioned Ruling Elder (CRE).

The Sacrament of Communion may be officiated by:

1. Teaching Elders
2. Commissioned Ruling Elders only within the congregation to which they are commissioned
3. Elders who have received training and been approved by the COM

The Sacrament of Baptism may be officiated by:

4. Teaching elders
5. Commissioned Ruling Elders only within the congregation to which they are commissioned
